A motion was made by Doug Wille, seconded by Pat Ramel and unanimously approved that Frandrups have four building sites on PIN 17-02700-010-50 and three building sites on PIN 17-03400010-75. A motion was made by Doug Wille seconded by Pat Ramel and unanimously approved to support Marian Frandrup's application. A letter will be sent to her stating the Townships approval.

Jerrold Otte has applied for the Farmland and Natural Areas Project "Saving Dakota County's Natural Heritage". A motion was made by Doug Wille, seconded by Pat Ramel and unanimously approved that Otte's have a total of three building sites on PIN 17-03300-010-51 and PIN 17-03300-014-75. A motion was made by Doug Wille, seconded by Pat Ramel and unanimously approved to support the application. A letter will be sent to him stating the Townships approval.

The Board received information from Brad Becker on the North Cannon River WMO. Doug will call Brad and find out what changes they are referring to and it will be discussed at the next meeting.

Dean Johnson from Resource Strategies is having a meeting at the Empire Township Hall on January 21, 2009. This is about the Comprehensive Plan. The Supervisors will attend this meeting.
