

Regular Board Meeting Minutes August 20, 2019 7:00pm

This meeting was called to order by Jim Sipe, Chair at 7:30pm with the Pledge of Allegiance to the flag and using the consent agenda. Doug Wille made a motion to approve the consent agenda except the claims and to approve the balance of the agenda. Dan Peine seconded it. Motion carried.

PUBLIC COMMENT

Deputy Smidt was present and said it has been quiet for them aside from random burglaries on the west side. They are watching the hands free. There has been some random mailbox theft more so on the east side of Dakota County now.

ROAD REPORT

- **Noxious weed control** Doug Wille talked to Emma Otte and we missed the boat for spraying wild parsnip. She recommended we talk to her about spraying it for us in February 2020.
- 230th & Hogan frost boils are being fixed. 250th east and west of 47 fixed another frost boil. Working with gas company on another one.
- **Gravel** 22nd from 50 to 47, 225th by Danny Endres (need to build up a little), Darkhorse-skip rock this year and work on culverts, 220th gravel has been done twice, did by Bill Tix and the dead end by 260th, maybe 250th west of 47 (3/4 of a mile), go by number of days or loads not weight. Jim Sipe will research this more.

PLANNING COMMISSION SYNOPSIS

Nick and Mary Niebur – 651-253-4119 requesting a permit for 24x22 foot addition on their home @ 25470 Lewiston Blvd, Hampton, MN 55031 consisting of a master bedroom with a bath

This is on the south side so there are no setback issues. The septic will need to be redone. John Leifeld is doing the addition and will take care of contacting Benny Svien and Darrel Gilmer. Doug Wille made a motion to approve the requested permit for Nick and Mary Niebur contingent on getting septic updated and working with Benny Svien for the permit needs. Dan Peine seconded it. Motion carried.

Tom Gergen - 507-291-0953

Tom Gergen was in requesting to build a shed @ 26493 Fischer Avenue, Randolph, MN 55065 on his property that he stated was 25 acres but was adding 1.25 acres to it from a land split from his father, Paul Gergen to meet the setbacks. The shed will be 60 x 60 cold storage, 80 x 60 heated and 30 x 30 office coming off of it with about 16 foot sidewalls. Tom and Jennifer Gergen's PID#17-02800-02-030 only shows 5.52 acres but Tom stated the 19 acre piece and that one should be in one deed from when they built their house. **Doug Wille made a motion to approve the AG permit for Tom Gergen. Dan Peine seconded it. Motion carried.** Jim Sipe signed the land split paperwork that Tom presented. Tom was advised that he will have to get it recorded with the county. **Jim Sipe made a motion to approve removing 1.25 acres from Paul and Lori Gergen PID#17-02800-75-010 and adding it to Tom and Jennifer Gergen PID#17-02800-02-030. Doug Wille seconded it. Motion carried.** Land split paperwork filed with the AG permit HT002-AG.

- Jim's draft of the temporary permit to exceed road restrictions-Jim will research this some more and get some help from Jason Otte and come up with a one page document.
- Special Meeting with Troy Gilchrist Jim sent us comments that Troy had. It is good information but we will maybe stick with what we got since most of the information is irrelevant to us. Planning Commission didn't like the sole discretion of the Board but that is what the Board does. The Board does not agree with doing a variance for everything. Troy is still working

on language for the other 4 which is a work in progress. The Board feels we are done with the clustering piece. Jim will send Jeremy Irrthum what he sent the Board and get the Planning Commission feedback on it. That way we can see if the Planning Commission comes up with anything.

- Pat Ramel 2020 Elections Andy Lokken from the county wanted cost for elections next year so Pat Ramel sent him that information. We will be reimbursed \$2,580.00 from the county for elections in 2020. We have 8 judges now, need 3 for township election and 4 for Super Tuesday (one week before the Township Election), the Primary and the General Election. There will be training in January and the clerk needs to attend also. 3 judges quit: Bob Bryant, Beth Piper and Judy Kimmes. We will need to approve the list of judges Pat Ramel sends to us contingent on their getting trained in January.
