This meeting was called to order by clerk, Molly Weber at 8:30pm. The Pledge of Allegiance to the flag was cited. Nominations for the Moderator were open. **Doug Wille nominated Jeremy Irrthum. Clerk, Molly Weber recapped the minutes from the 2018 Annual Meeting citing motions that took place.

Financial Report - The financial report of the township was read by Leo Nicolai.

Jim Sipe made a motion to approve accepting the Financial Report. Dan Peine seconded. Motion carried.

Road Report – Doug Wille summarized the 2018 Road Report which is attached. Some planned work was completed. Some was not. Generally speaking, the roads are in pretty darn good shape. Plowing has been done in a timely manner. There were one or 2 complaints in the last year about dust and one snow complaint this winter. Generally speaking, Otte's have done a good job the last few years. Per Pat Ramel there were compliments at today's election that the roads were in good shape. Response time very good. Road Tour Report (attached), the only significant need is to replace 2 culvert delineators on Dark Horse Lane if we need to do that this year.

Pat Ramel made a motion that we accept the road report. Leo Nicolai seconded it. Motion carried.

Board of Audit Report – Jim Sipe stated the Board of Audit met on 02/16/19 and reviewed the Township's accounts for 2018. Everything matched between the Treasurer and the Clerk. The treasurers report was accepted for 2018. A levy recommendation was given to bring to the Annual meeting:

General Fund	\$60,000.00
Road and Bridge Fund	\$180,000.00
Fire Fund	\$42,000.00
Total	\$282,000.00

The total remains the same from 2018 based on how much we are paying for fire and we had some surpluses from previous years. We changed the three a little bit to align with past expenses. We took \$2,000.00 from the Road and Bridge and added it to the Fire fund. Leo Nicolai stated the one other thing that was in line was to take \$50,000.00 out of the General Fund and \$50,000.00 out of the Road and Bridge fund and put it with our CD. Our CD is \$70,000.00. This amount will bring the total to \$170,000.00. Doug Wille stated that years ago the Township Association recommended to have an additional 6 to 12 months of operating expenses available. We have maintained the roads quite well the last few years but eventually we will have to make some expensive improvements. Last Thursday (03/07/2019) Doug Wille attended the Fireman's meeting and Chief Witson said they intend to hold the line on our contract for the next couple years. They have about 170 calls per year which are more medical and car accidents. Small percentage is fires. Doug Wille made a motion that we accept the Board of Audit Report. Jeff Werner seconded. Motion carried.

Doug Wille made a motion to that we waive the reading of all the checks written and received. Jim Sipe seconded. Motion carried.

Pat Ramel made a motion that we approve the Levy for the General Fund of \$60,000.00 payable in 2020. Dan Peine seconded it. Motion carried.

Doug Wille made motion that we approve the Road and Bridge Levy for \$180,000.00 payable 2020. Leo Nicolai seconded. Motion carried.

Pat Ramel made a motion to approve the Fire Levy at \$42,000.00 payable 2020. Dan Peine seconded. Motion carried.

Annual Election Report – total casted votes was 13, and 2 absentee votes all 15 votes were for Dan Peine. No overvotes. No undervotes. Dan Peine was re-elected for 3 year term. Current election terms do not end until the Reorganization Meeting.

General discussion-such imput is only advisory to the board: Jim Sipe wondered if we should considered scheduling the township election during the General Election. General elections are every other year. Township elections are annual. We have the choice to do March or November but we would need to put it on the ballot to vote on it. We talked to Minnesota State Senator Matt Little (District 58) about mail ballots but the state only allows it for small voting districts. The legislator has talked about raising that number and we requested it raised to 1000 since we have just under 600. Township elections expenses are \$500 - \$1,000 most due to election judge wages. Every other year we would save about \$500.00 to \$1,000.00. This is not much of a savings. Coinciding with general elections might generate a little more appeal for people to come. It is best to recommend the Board to look at this. Jim Sipe will ask at the MAT training next week what other townships do and why. Per Senator Little the mail turn in is higher than live voting. The county takes care of the mailing of ballots. Jim Sipe made a motion that we ask the Board to consider changing the township election to November. Dan Peine seconded. Motion carried.

Leo Nicolai made a motion to have the Annual Meeting in 2020 at 8:30pm on the second Tuesday of March after the elections. Inclement weather will be the 3rd Tuesday in March 2020. Pat Ramel seconded it. Motion carried.

ADJOURNING OF MEETING

Jim Sipe made a motion to adjourn the meeting at 9:10pm. Pat Ramel seconded. Motion carried.
