

Regular Board Meeting Minutes October 15, 2019 7:00pm

This meeting was called to order by Jim Sipe, Chair at 7:30pm with the Pledge of Allegiance to the flag and using the consent agenda. Doug Wille made a motion to approve the consent agenda except the claims and to approve the balance of the agenda. Dan Peine seconded it. Motion carried.

Deputy Omeara was in to introduce himself. He discussed a high-speed chase that occurred this past week. He mentioned the Next-Door app that tells you what is going on.

ROAD REPORT

Jim Sipe requested that Jason Otte get us itemized bills since we have spent twice as much as we did last year. We did not have many projects last year. This year we have about \$30,000. In snow removal and road rebuilds. 250th and 260th roads are really good. Lewiston does not have enough fines in the road, it is too rocky. Jason Otte was told by another township that the road threshold changed from \$100,000. to \$175,000. Jim Sipe said he would check into this. Doug Wille stated there have been no complaints and that the roads look good.

He said they took the house down about a year ago and hauled it all away. This property is in the Vermillion River Watershed but not in the wetland. He plans to store corn, hay, feed and farm equipment in the shed. Dave presented his AG permit that he hopes to build right away. Doug Wille made a motion to approve the 50x140 shed located at 5420 240th Street East in Hampton, MN. Dan Peine seconded it. Motion carried.
