RESOLUTION APPROVING SUMMARY LANGUAGE FOR PUBLICATION OF AN ORDINANCE REGULATING TOWN RIGHT-OF-WAYS

WHEREAS, on April 15, 2014 the Town Board of Hampton Township adopted ordinance No. 2014-1 "An Ordinance Regulating Town Road Right-of-Ways and the Impacts from Large Utility Projects" (the "Ordinance");

WHEREAS, it is not practical to publish the entire text of the Ordinance in the Town's official newspaper;

WHEREAS, Minnesota Statute, section 365.125, subdivision 2 allows the publication of a summary of an ordinance instead of publishing the entire ordinance; and

WHEREAS, the Town Board determines publication of a summary of the Ordinance is sufficient to clearly inform the public of the intent and effect of the Ordinance.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby determines to publish the following summary language, which is hereby approved, in lieu of publishing the full text of the Ordinance:

HAMPTON TOWNSHIP DAKOTA COUNTY, MINNESOTA

AN ORDINANCE REGULATING TOWN ROAD RIGHT-OF-WAYS AND THE IMPACTS FROM LARGE UTILITY PROJECTS Ordinance 2014-1

The Town Board adopted Ordinance No. 2014-1 to impose regulations on those excavating within or obstructing Town right-of-ways for the installation of utility facilities. Those proposing to undertake such work must obtain a permit from the Town, pay the applicable fees, and comply with standards regarding the work and the restoration of the right-of-ways. The ordinance also requires a permit for those undertaking a large utility project within the Town affecting its right-of-ways. The ordinance establishes a permitting process, requires submission of an application fee, escrow, and construction security, provides for a road use agreement, and imposes standards regarding the restoration of right-of-ways. A copy of the full ordinance is available at the Hastings Public Library, is posted on the Town's website, and is available by contacting the Town Clerk.

- (e) Place a copy of the full Ordinance at the Dakota County Law Library; and
- (f) Place the Ordinance in the Town Ordinance Book within 20 days together with a copy of the affidavit of having published the approved summary language.
